REPUBLIC COUNTY BOARD OF COMMISSIONERS' MINUTES MONDAY, JANUARY 6, 2020

The Republic County Commission met in regular session on Monday, January 6, 2020, at 8:30 a.m. Commissioners present were Edwin Splichal and Melvin Jeardoe. Marvin Bergstrom was absent. Clerk Kathleen Marsicek was present to record the minutes. Deb Hadachek from The Belleville Telescope monitored the meeting.

The meeting was called to order and attendees pledged allegiance to the flag of the United States of America.

- Zenger is requesting bids for culverts, tires and bridge inspection during 2020.
- Crews are removing trees along Timber road.
